There would be an initial due diligence term of 120 days fir the lessee to assess the suitability of the site. If site is deemed suitable, the lessee, under the current terms of the draft agreement, would pay Anchor Bay School District \$220 per acre per year with a 2% escalation of the lease payment each year. The draft lease also calls for an initial lease term of 25 years with options to extend the lease into the future, lease will be subject to approval of outside legal counsel. A lease of the property, as described above for the initial term of 25 years, would result in the District receiving rental revenue of over \$2,800,000.
